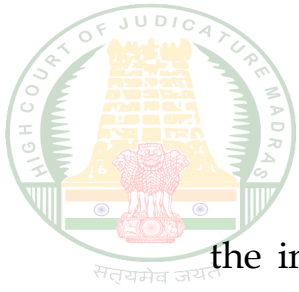

ORDER

The Petitioner herein seeks a direction to the fourth respondent to conduct survey and demarcation in respect of the land bearing S.No.635/3B, situated at Tharuvai Village, Palayamkottai, Tirunelveli District.

2.Mr.A.Baskaran, learned Additional Government Pleader takes notice for the respondents 1 to 4. By consent of both parties, the Writ Petition is taken up for final disposal at the admission stage itself.

3.According to the Petitioner, the subject property was purchased by him under registered sale deed, dated 8.10.2020. Patta fo the subject property was issued in the name of Petitioner in Patta No.3824. He submitted an online application on 15.03.2025 in Application No.2025/0123/29/003963 seeking survey of the subject property. The same has not been considered so far. Hence

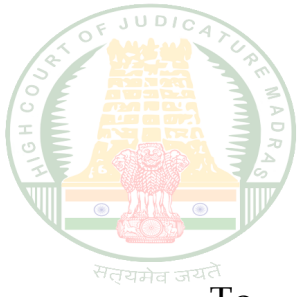
