The same has not been considered till date. Hence the Petitioner is before this Court with the present Writ Petition for the aforesaid relief.

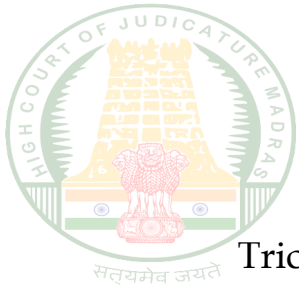
