3. By consent of both the parties, the writ petition is taken up for final disposal at the stage of admission itself.



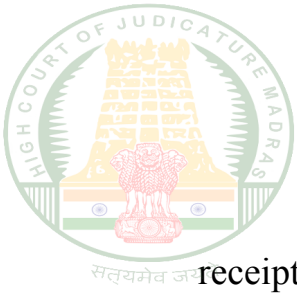

4. According to the petitioner, the subject property was purchased by him under a registered Sale Deed dated 05.07.2002. The Patta for the subject property stands in the name of the petitioner in Patta No.4603. He submitted an online application on 27.05.2025 in மனு எண்: 2025/0123/27/005945, seeking survey of the subject property and the same has not been considered. Hence, the petitioner has come before this Court.

5. The learned Additional Government Pleader who takes notice for the respondents 1 and 2 would submit that the 4th respondent is making objection to survey of the subject property by claiming right over S.No.418/1A1A. Therefore, the survey process has not been carried out.

6. In the light of the submission made by the learned Additional Government Pleader appearing for the respondents 1 and 2, this Court is inclined to direct the 1st respondent to consider the online application of the petitioner dated 27.05.2025 and pass final orders on its own merits and in accordance with law within a period of eight (8) weeks from the date of
