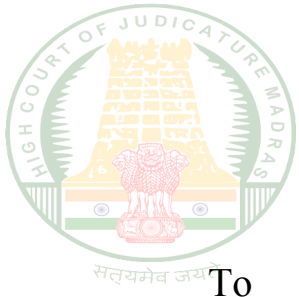

3.Considering the manner, in which, the complaint of the year 2023 has been registered with the First Information Report in the year 2025, this Court directs the Superintendent of Police, Madurai, to withdraw the case in Crime No.102 of 2025 from the file of the respondent police and entrust the same to some other investigation officer, to conduct a fair investigation in the above crime number.
