### **ORDER**

When the matter was taken up for hearing on 24.06.2025, none appeared for the petitioner. Thus, Registry was directed to list the matter under the caption 'for dismissal' on 26.06.2025. 2.This Writ Petition has been instituted, challenging the notice dated 28.07.2023 issued by the Trichy Corporation. The impugned notice is relating to
