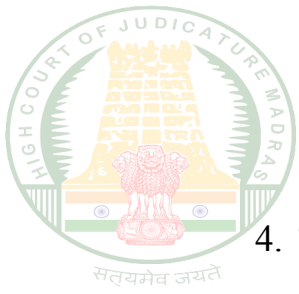

ORDER

This petition has been filed seeking to expedite the proceedings in O.S.No.505 of 2022 on the file of the Principal Sub Court, Tenkasi.

2. The deceased one Raja @ Kumarasamy filed a suit in O.S.No.505 of 2022 on the file of the Principal Sub Court, Tenkasi against the respondents herein seeking declaration and permanent injunction.

3. Since no adverse orders are going to be passed against the respondent Nos.4 to 9, notice to the respondent Nos.4 to 9 is dispensed with.
