ORDER

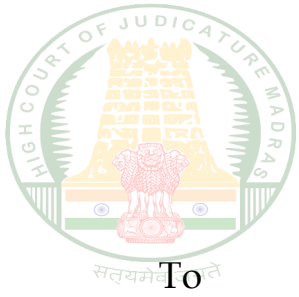
The petitioner, with a grievance that his representations dated 11.08.2021 and 04.03.2018 have not been considered by the second respondent, has filed this writ petition.
