Accordingly, this Court directs the first respondent to pass final orders on merits and in accordance with law on the petitioner's representation dated 05.09.2022, seeking for payment of arrears of interest for the subscription amount deducted from the salary of the petitioner towards General Provident Fund while the petitioner was in service along with Dearness Allowance Arrears and Vth Pay Commission Arrears and Revised Pay Commission arrears, within a period of twelve [12] weeks from the date of receipt of a copy of this order.

5. With the aforesaid direction, this Writ Petition stands disposed of. There shall be no order as to costs.
