2.Based on the petitioner's complaint, Crime No.205 of 2023 was registered by Colacheal Police Station. The respondents have filed status report. The stand of the respondents is that the minor children were found entering harbour and that they have not been seen ever since. The respondents appear to have done their very best. However, it is stated in the status report that investigation is still proceeding. We are satisfied
