ORDER: The Court made the following order :-

This petition has been filed for extension of time for compliance of the conditional order passed in Crl.O.P.(MD).No.5523 of 2025 dated 25.04.2025.

2. The learned Counsel for the petitioner would submit that this Hon'ble Court passed an order in Crl.O.P.(MD).No.5523 of 2025 dated 25.04.2025 and this Hon'ble Court enlarged the petitioner on anticipatory bail. Due to personal inconvenience, this petitioner is not able to arrange sureties and produce before the concerned Court.
