This petition has been filed for extension of time for compliance of the conditional order passed in Crl.O.P(MD).No.11031 of 2025 dated 01.07.2025.

2. The learned Counsel for the petitioners would submit that this Hon'ble Court passed an order in Crl.O.P(MD).No.11031 of 2025 dated 01.07.2025 and enlarged the petitioners on anticipatory bail by imposing certain conditions. He further submits that the order copy was uploaded only after fifteen days, these petitioners are unable to produce surety and surrender before the concerned Court within the time stipulated by this Court.
