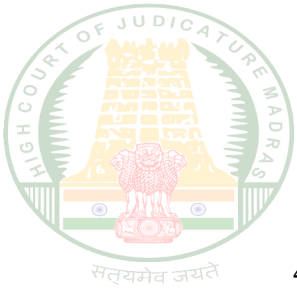

4. According to the petitioner, the subject property originally stood in the name of the petitioner's mother in Patta.No.2020. Thereafter, she executed a Settlement Deed in favour the petitioner under a registered Settlement Deed dated 28.05.2024. Patta for the subject property also stands in the name of the petitioner in Patta No.2020. He submitted an application on 19.06.2025 in மனு எண்:2025/N123/23/007135, seeking survey of the subject property. However, the same has not been considered till date. Hence, the petitioner has come before this Court.

5. The learned Additional Government Pleader who takes notice for the respondents 1 and 2 would submit that the online application submitted by the petitioner dated 19.06.2025 will be considered within the time stipulated by this Court.

6. In view of the same, without expressing any opinion on the merits of the matter, the respondents 1 and 2 are directed to consider the online application of the petitioner dated 19.06.2025 and pass final order on its own merits and in accordance with law within a period of eight (8) weeks from the date of receipt of a copy of this order.
