PRAYER: Civil Revision Petition is filed under Article 227 of Constitution of India, praying to strike off the petition in D.V.C.No.8 of 2025, on the file of the Principal District Munsif cum Judicial Magistrate, Thiruppathur, Sivagangai District.

ORDER

This petition has been filed seeking to strike off the proceedings / petition in D.V.C.No.8 of 2025, on the file of the Principal District Munsif cum Judicial Magistrate, Thiruppathur, Sivagangai District.

2.The first respondent filed D.V.C.No.8 of 2025, on the file of the Principal District Munsif cum Judicial Magistrate, Thiruppathur, Sivagangai District against her in-laws under the provisions of the Domestic Violence Act and BNSS, 2023.

3.The learned counsel appearing for the petitioners submits that the petitioners are the family members of the first respondent's husband. The first respondent has initiated domestic violence proceedings against them. It is

submitted that the petitioners are in no way connected with the allegations made by the first respondent in the DVC case. Therefore, he prays that the petitioners may be permitted to raise all the grounds mentioned herein before the trial court. He also requests this Court to dispense with their personal appearance before the trial court.

4. In view of the nature of the order which this Court is going to pass, which in no way affects the respondents, notice to the respondents is dispensed with.

5. This Court, taking into consideration the submission made by the learned counsel for the petitioners, permits the petitioners to raise all the grounds as raised herein before the trial court at the time of trial. Taking into consideration the request made by the learned counsel for the petitioners, their appearance before the trial court is dispensed with except for their appearance for the purpose of receiving the copy of the proceedings u/s 230 of BNSS, framing of charges, questioning under Section 351 of BNSS and on the day on which judgment is to be pronounced. However, if for any particular reason, the presence of the petitioners is necessary, the trial court, at its wisdom, shall direct them to appear on those days.
