(Order of the Court was made by the Hon'ble G.R.SWAMINATHAN J.)

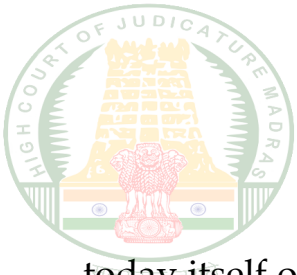
This third party writ appeal is directed against an interim order passed by the learned single Judge.
