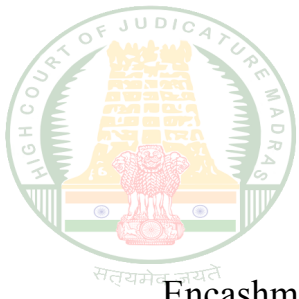

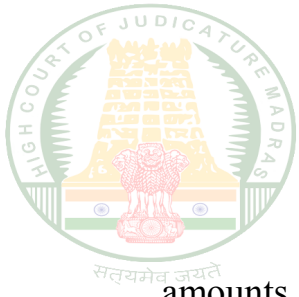

ORDER

The present writ petition has been filed by a retired employee of the respondent Transport Corporation, who attained superannuation on 30.06.2023.

2. According to the writ petitioner, his terminal benefits were released only on 16.04.2025 and 17.04.2025. Hence, he has sent a representation on 21.04.2025 seeking interest for the belated payment of terminal benefits. Since there is no response, the present writ petition has been filed.

3. Considering the above said facts, the respondents herein are directed to pay interest at the rate of 6% from the due date till the date on which the
