PRAYER: Writ Petition filed under Article 226 of the Constitution of India, praying this Court to issue a Writ of Mandamus, directing the respondent to revise/re-fix the scale of pay of the petitioner w.e.f. 01.09.2019 to till her retirement, based on the wage settlement dated 24.08.2022 and consequently to pay her difference/arrears of wages for the period from 01.09.2019 to 31.07.2022 and also terminal benefits namely Gratuity and Encashment of Leave, after revising the same based on such re-fixed scale of pay payable to her on the month of her retirement, together with 18% interest per annum, within a time frame as may be fixed by this Court.

ORDER

The present Writ Petition has been filed by a retired employee of the respondent Transport Corporation seeking a Mandamus to disburse the difference of wages arising out of 14th wage settlement, dated 24.08.2022.

2. According to the learned counsel appearing for the writ petitioner, the petitioner had attained superannuation on 31.07.2022 and the 14th wage settlement was entered into on 24.08.2022 with retrospective effect from 01.09.2019. The petitioner has sent a representation to the respondent on 02.06.2025 seeking arrears of terminal benefits. Since there is no response, the present writ petition has been filed.

3. Heard the learned counsel appearing for the petitioner and the learned Standing Counsel appearing for the respondent.
