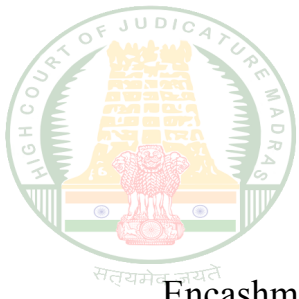

2. According to the writ petitioner, her terminal benefits were released only on 16.04.2025. Hence, she has sent a representation on 17.04.2025 seeking interest for the belated payment of terminal benefits. Since there is no response, the present writ petition has been filed.

3. Considering the above said facts, the respondents herein are directed to pay interest at the rate of 6% from the due date till the date on which the amounts were disbursed to the writ petitioner, within a period of twelve (12) weeks from the date of receipt of a copy of this order.
