3.Considering the limited scope of the prayer sought for by the petitioner, without expressing any opinion on the merits of the claim made by the petitioner either in the representation or in the affidavit filed in support of this Writ Petition, we direct the respondents 1 to 6 to consider the representation of the petitioner dated 13.06.2024, after giving sufficient opportunity of personal hearing to the petitioner and the respondents 7 and 8 and pass appropriate orders on merits and in accordance with law within a period of twelve (12) weeks from the date of receipt of a copy of this order.
