2.Heard the learned counsel appearing for the petitioner and perused the materials placed before this Court.

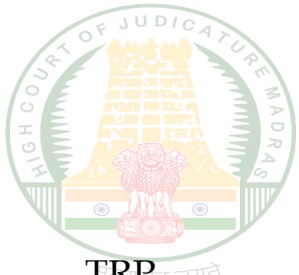
