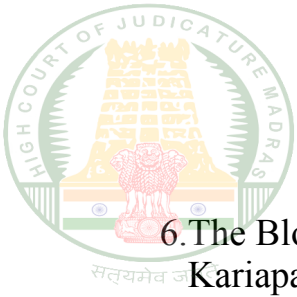

2.The project requires financial sanctioning from the competent authorities. Therefore, High Court cannot issue any positive direction to lay thar road through cart track. Whether it is a necessity or not is to be assessed based on various factors prevailing in that locality. Thus, the petitioner has to approach the 6th respondent for submitting necessary proposal if required to the competent authority for financial sanctioning and to lay thar road in the cart track.

3.With the above observations, this Writ Petition is disposed of. No costs.
