ORDER

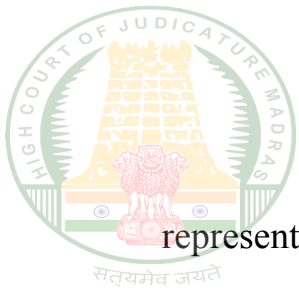
(Order of the Court was made by A.D.JAGADISH CHANDIRA,J.)
