ORDER

(Order of the Court was made by J. NISHA BANU, J.)

It is the grievance of the petitioner that his representation dated 19.07.2024, to remove the encroachment made by the respondents 6 to 9 in the common pathway situated in Government poramboke land, is kept pending till date without any progress. Therefore, he has filed this Writ Petition with the aforesaid prayer.

2.The learned Special Government Pleader appearing for the respondents 1 to 3 & 5 submits that the representation of the petitioner would be considered and appropriate orders would be passed on its own merits within a period that may be stipulated by this Court.

3.Considering the limited scope of the prayer sought for by the petitioner, without expressing any opinion on the merits of the claim made by the petitioner either in the representation or in the affidavit filed in support of this Writ Petition, we direct the respondents 1 to 4 to consider the representation of
