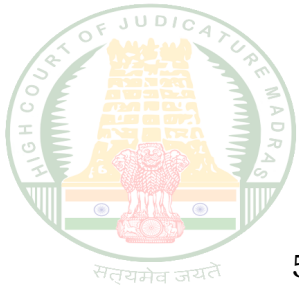
the learned Judicial Magistrate No.1, Pudukkottai.
