This petition has been filed for extension of time for compliance of the conditional order passed in Crl.O.P(MD).No.10532 of 2025 dated 25.06.2025.

2. The learned Counsel for the petitioners would submit that this Hon'ble Court passed an order in Crl.O.P(MD).No.10532 of 2025 dated 25.06.2025 and enlarged the petitioners on anticipatory bail by imposing certain conditions. He further submits that the petitioners herein are unable to arrange sureties and hence they are unable to appear before the Court within the stipulated time.
