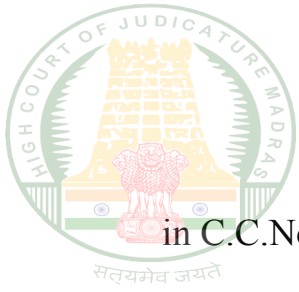

3	918/2022	294(b), 324, 506(2) of IPC, 4 of TN Prohibition of Harassment of Women Act, 2002	Charge sheet filed, taken on file in C.C.No.46 of 2023 before District Munsif Cum Judicial Magistrate, Papanasam.
