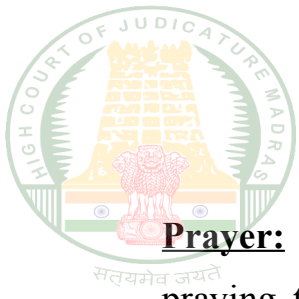

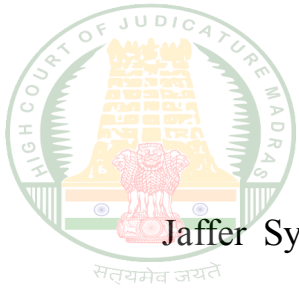

4. Registry is directed to carry out necessary amendments in the cause title.

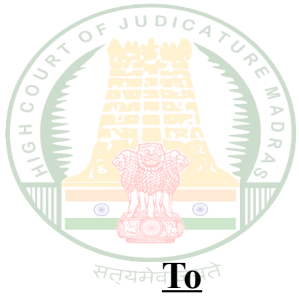
