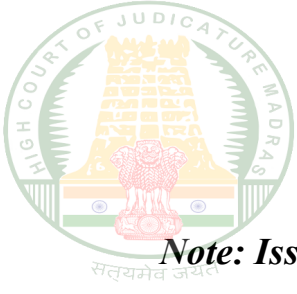
3. It is noticed that the petitioner has paid necessary charges for putting up the flex board on 23.07.2025.
