ORDER

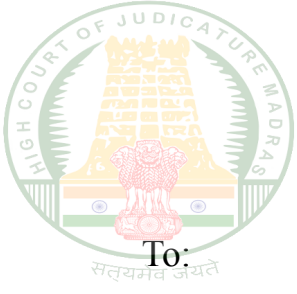
