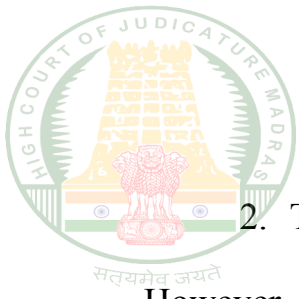

However, the temple, namely Arulmigu Subramania Swamy Thirukovil, is claiming right over the said property.

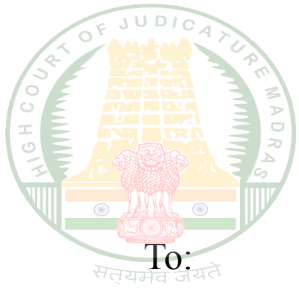
