2.This miscellaneous petition is allowed accordingly."

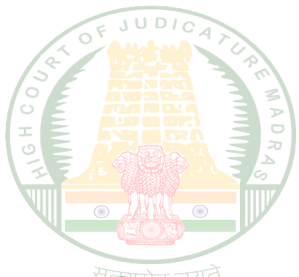
