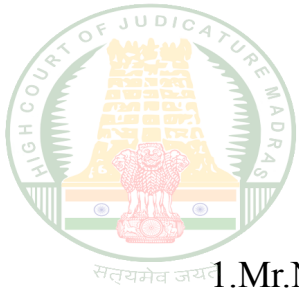
3.Preserving the rights of the writ petitioner to ventilate his grievance over non-disbursed portion, this contempt petition stands closed. No costs.
