ORDER

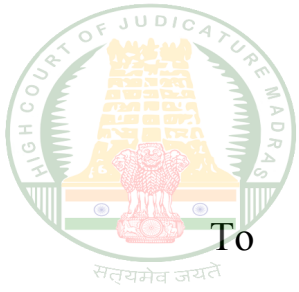
The petitioner has filed this petition for a direction to the respondent police not to grant permission for conducting cultural programme beyond 10pm as it disturbs the elderly and sick people.
