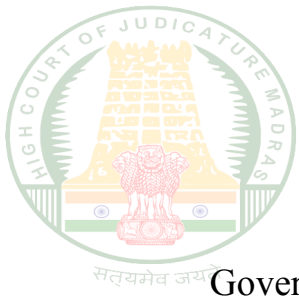

Government Advocate appearing for the respondents 1 to 5. By consent of both sides, this Writ Petition is taken up for final disposal at the admission stage itself.

3. According to the petitioner, the subject property was gifted to him by his father under a gift deed dated 14.05.2025. The patta for the subject property stands in the name of the petitioner, his siblings and his mother in Patta No.3108. The petitioner submitted an application on 01.07.2025 in Application No.2025/0123/24/017238, seeking survey of the subject property. The same has not been considered. Hence, the petitioner has come before this Court.

4. The learned Government Advocate appearing for the respondents would submit that the application submitted by the petitioner will be considered in accordance with law.

5. In view of the same, without expressing any opinion on the merits of the matter, the respondents 2 and 3 are directed to consider the online application of the petitioner dated 01.07.2025 and pass final
