This petition has been filed for extension of time for compliance of the conditional order passed in Crl.O.P(MD).No.6910 of 2025 dated 25.04.2025.

2. The learned Counsel for the petitioner would submit that this Hon'ble Court passed an order in Crl.O.P(MD).No.6910 of 2025 dated 25.04.2025 and enlarged the petitioner on anticipatory bail by imposing certain conditions. He further submits that the order copy was made ready on 27.05.2025. After receiving the order copy , he suffered with severe scrotum pain and hence he was admitted in hospital, he is unable to produce surety before the concerned Court and unable to deposit the amount of Rs.1,80,000/- to the credit of Cr.No.152 of 2023 within the time stipulated by this Court.
