4. With the above directions, this writ petition stands disposed of. There shall be no order as to costs.

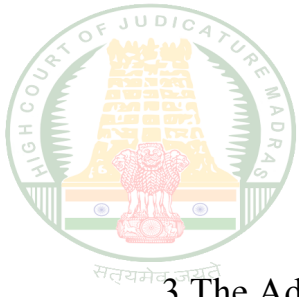
