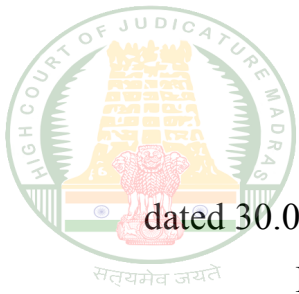

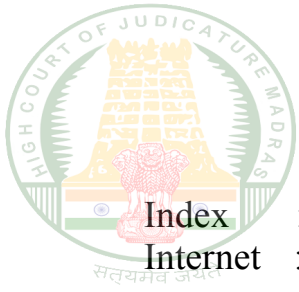
3.Recording the above said submission, this Court is directing the respondents to take appropriate action in accordance to law within a period of four weeks from the date of receipt of a copy of this order.
