ORDER

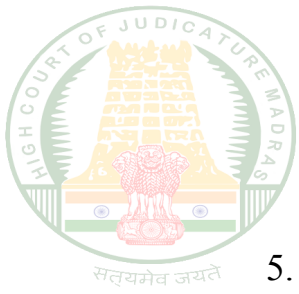

This Writ Petition is disposed of at the time of admission after hearing the learned counsel for the petitioner and the learned Standing Counsel for the respondent.

2. It is the case of the petitioner that he has provided service to the respondent and that sum of Rs.71,24,254/- is due payable to the petitioner.

3. The learned counsel for the petitioner would submit that the petitioner has also given representation, dated 25.06.2025. However, the said representation has not evoked a positive response.

4. The learned counsel for the petitioner has placed reliance on a decision of this Court rendered in ***W.P(MD) No.14699 of 2022 dated 26.07.2022*** in the case of ***Dream Infra Vs. The Managing Director, Tirunelveli Smart City Limited, Tirunelveli*** and in the case of ***Quadrantpole Private Limited Vs. The Managing Director, Tirunelveli Smart City Limited, Tirunelveli in W.P(MD) No.23555 of 2022, dated 03.12.2024.***

5. It is noticed that in the above said cases, there was a positive direction to consider the representation of the petitioner therein. I find no reasons to take a different stand.
