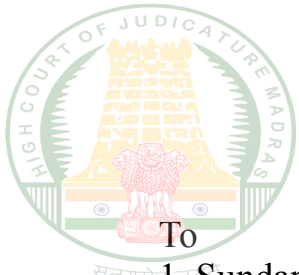
Alleging wilful disobedience of the order passed in W.P.(MD)No. 10300 of 2024, this Contempt Petition has been filed.
