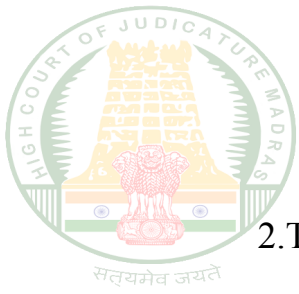
JUDGMENT

Challenging the order of the learned Single Judge directing the respondents viz., The State as well as the Chief Nodal Officer, National Health Insurance Scheme, to quantify the amount of reimbursement to the petitioner, who took treatment in a non-network hospital.
