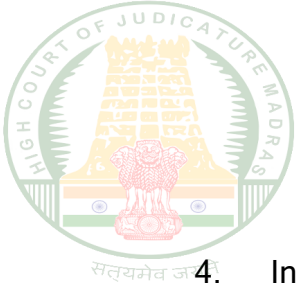

ORDER

This Writ Petition has been filed under the Article 226 of the Constitution of India, to issue a Writ of Certiorarified Mandamus, challenging the order passed by the 2nd respondent dated 15.11.2021 and consequent order passed by the 3rd Respondent dated 16.11.2021 and consequent order passed by the 4th respondent dated 19.11.2021 and directing the respondents No.2 to 4 to regularize the service of the Petitioner from the period of 17.11.2011 to 26.01.2016 with all consequent monetary benefits in the light of the observation made in W.P.(MD)No.13830 of 2011 dated 02.08.2012 and W.P.(MD)No.7814 of 2021 dated 15.04.2021.
2. When the matter was taken up for hearing, Mr.K.K.Kannan, learned counsel for the Petitioner, submitted that the Petitioner does not wish to press the Writ Petition and has circulated a letter in this connection. He had also made an endorsement to that effect in the affidavit filed in support of this Writ Petition.
3. Mr.F.Deepak learned Special Government Pleader for the Respondents stated that he had no objection.
