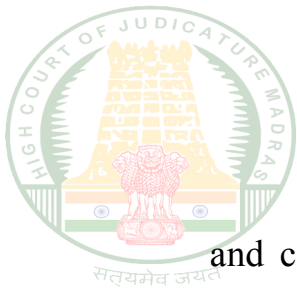

The learned Special Government Pleader appearing for the petitioner seeks permission of this court to withdraw this petition, as they have complied with the orders.

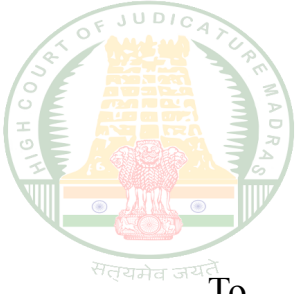
2.Permission is granted. Accordingly, this writ petition is dismissed as withdrawn. Consequently connected miscellaneous petition is closed.
