The petitioners, who apprehend arrest at the hands of the respondent police for the offence punishable under Section 318 BNS, 2023 in Crime No. Not Known of 2025, seek anticipatory bail.

2. Today, when the matter is taken up for hearing, the learned Government Advocate (Criminal Side) appearing for the respondent police, on instructions, submitted that enquiry is pending is CSR.No.505 of 2025 against the petitioners.

3. The learned counsel appearing for the petitioners submitted that the respondent police is harassing the petitioners under the guise of enquiry.

4. Considering the facts and circumstances of the case, the respondent police is directed to follow the procedure under Section 35 of BNSS, and to conduct the enquiry and if any prima facie case is made out against the petitioners, register the F.I.R. or close the petition enquiry within a period of two weeks from the date of receipt of a copy of this order.

5. Till such time, the petitioners shall not be arrested by the respondent police.

6. With the above directions, this criminal original petition is disposed of.
