“8(iii)The petitioner shall stay at Chennai and report before the Inspector of Police, Flower Bazaar Police Station, New Broadway Bus Stop, Chennai, daily at 10.30 am., until further order.”

3.The learned counsel appearing for the petitioner submits that the petitioner is a resident of Kanyakumari District and in compliance of this Court order dated 01.07.2025, he is residing at Chennai and appear before the Flower Bazaar Police Station, New Broadway Bus Stop, Chennai, daily at 10.30 am., until further order.

He is financially unstable to stay at Chennai and he has no source to manage day to day affairs. Hence, he prays to modify the condition.
