This petition has been filed for extension of time for compliance of the conditional order passed in Crl.O.P(MD).No.10987 of 2025 dated 30.06.2025.

The learned Counsel for the petitioner would submit that this Hon'ble Court passed an order in Crl.O.P(MD).No.10987 of 2025 dated 30.06.2025 and enlarged the petitioner on anticipatory bail by imposing certain conditions.
