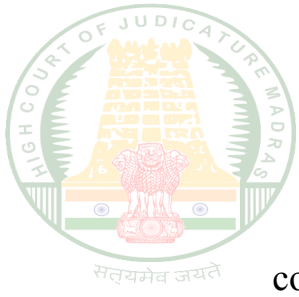

quash the same and consequently direct the respondents herein to issue Death Certificate to the petitioner grandfather namely, Antony S/o.Savari, who died on 05.01.1989 at Uthamapalyam, Uthamapalyam Taluk, Theni District.

2. When the matter was taken up for hearing, Mr.C.Senthil Murugan, learned counsel appearing for the petitioner submitted that he does not wish to press the Writ Petition as the translated copy has not been filed properly. He has also made an endorsement to that effect in the affidavit filed in support of the Writ Petition.
3. Mr.S.Shanmugavel, learned Additional Government Pleader for the Respondents stated that he had no objection.
