2. Recording the same, this Writ petition stands dismissed as infructuous. No costs. Consequently, connected Miscellaneous Petitions are closed.

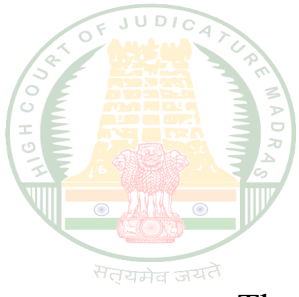
