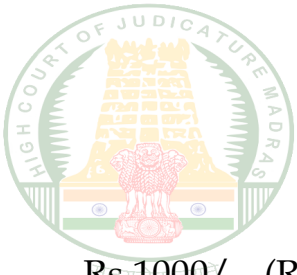
This petition is filed to condone the delay of 418 days in filing the above Writ Appeal.
