Connection Number - 297 (Door No.220 S.No.220/19B, at Puliathamman Village, Kalaiyarkovil Taluk, Sivagangai District and restore the same in the name of the petitioner by considering the petitioner's representation dated 25.06.2025.

3.It is noticed that the third respondent has already secured a favourable decree in O.S.No.208 of 2010, wherein, the settlement deed, dated 21.10.2009, has been confirmed.
