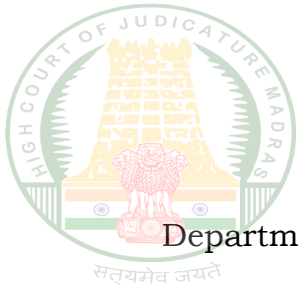

ORDER

2. Heard the learned counsel for the petitioner and the learned Government Advocate appearing for the respondents.

3. The issue for consideration in this writ petition is the determination of staff strength with reference to the total student strength in the petitioner's institution. Accordingly, this writ petition is disposed of with a direction to the petitioner to furnish the present student strength of both the Tamil Medium and English Medium sections of the Higher Secondary School. On receipt of the said particulars, the second respondent shall fix the staff strength in accordance with G.O.Ms.No.525, School Education
