ORDER

This petition has been filed for extension of time for compliance of the conditional order passed in CrI.O.P(MD)No.8635 of 2025 dated 17.06.2025.

2. The learned counsel appearing for the petitioner would submit that this Court passed an order in CrI.O.P(MD)No.8635 of 2025 dated 17.06.2025 and enlarged the petitioner on anticipatory bail. He would further submit that due to the health condition of the petitioner, he is unable to execute the surety and surrender before the concerned Court within the time stipulated by this Court. For the said reason only, he is unable to comply the conditions imposed by this Court in CrI.O.P.(MD)No.8635 of 2025 dated 17.06.2025. Hence, he prayed to extend the time period, by allowing this Criminal Miscellaneous Petition.
